Audit of Study Skills Tutors and Non-Medical Helper (NMH) providers

All NMH providers are expected to ensure that NMH support workers delivering Disabled Student Allowance (DSA) funded roles have the relevant qualification and professional body membership requirements as set out by Department for Education (DfE).

From September 2020 DfE will be introducing a programme of auditing of NMH support worker qualifications. Those selected for audit will be asked to provide evidence for workers who have delivered DSA-funded NMH roles in the 12 months prior to the audit. Details of the audit can be found here.

Those Guild members with ADG FE/HE grades are subject to Band 4 Specialist one-to-one Study Skills and Strategy Support – Specific Learning Difficulties (SpLD) and details can be found here.

Seeking ADG FE/HE provisional membership?

The Dyslexia Guild has a clearly defined membership grade for Study Skills Support Tutors which is Associate Member Further and Higher Education (ADG FE/HE).

Applicants should be working towards gaining the Level 5 Certificate in Supporting Adults within a specified time period. This qualification comprises 6 units each of 30 hours of study/2 Awards. In the first instance, ADG FE/HE provisional applicants may be asked to complete at least 3 units of this qualification before membership is granted and will then be expected to complete the remaining 3 units within the next two years.

Courses run in September, November, January, March, May and July.

Access Arrangements Update

We are very pleased to let you know that the 2020/21 Access Arrangements Update course - free of charge with Real Training - is now complete and free for you to access. As a reminder, those registering for the free Access Arrangements Update will:

- · Gain 3 SASC-accredited Continuing Professional Development (CPD) hours upon completion
- Be fully up to date with the new Joint Council for Qualifications (JCQ) guidelines and requirements for the academic year 2020/21
- Have access to a popular forum to ask questions of both peers and tutors about specific challenges
- Be able to work through the course in their own time, as it is fully online and set out in a series of strands
- · Have access to a certificate of completion

Critical Thinking and Fake News



Sense about Science, an independent charity that champions public interest in science and evidence, have worked with young people around the UK in the design of resources and activities to enhance their information literacy. The 2018 Commission on Fake News concluded that half of teachers feel the national curriculum does not equip children with the skills they need to identify fake news and a third of teachers feel the critical thinking skills taught in schools aren't transferable to the real world. Benefits of video games for literacy



The National Literacy Trust in partnership with the Association of UK Interactive Entertainment (Ukie) and Penguin Random House Children's Publishing, has published research that found that 4 in 5 (79%) young people who play video games read materials relating to video games regularly, including ingame communications (40%), reviews and blogs (31%), books (22%) and fan fiction (19%). A third (35%) also believe that playing video games makes them better readers.

To further support young people's literacy through video games, they have launched a range of activities, challenges and resources for young people, parents and teachers to explore. Find out more here.

Two Medal Winners in 2020 prestigious book awards



Lark by Anthony McGowan (Barrington Stoke) scoops the Carnegie Medal for writing, whilst Tales from the Inner City written and illustrated by Shaun Tan (Walker Books) takes the Kate Greenaway Medal for illustration.

Both books use captivating words and images to explore humankind's relationship with nature, alongside themes of survival.

The winning books were chosen by 14 volunteer Youth Librarians, from a total of 162 nominations this year, as the very best in children's writing and illustration published in the UK. The winners will each receive £500 worth of books to donate to a library of their choice, a specially commissioned golden medal and a £5,000 Colin Mears Award cash prize.

CILIP, the Chartered Institute of Librarians and Information Professionals, will celebrate the conclusion of the Shadowing Scheme by announcing the winners of the Shadowers' Choice Award – voted for and awarded by the children and young people who shadow the Medals – on 9th October 2020, during National Libraries Week.

Period Poverty

Charities say many schools and colleges are not aware they can order free period products through a government scheme, amid concerns Covid-19 has left more pupils struggling to access and afford

tampons and pads.

Gemma Abbott, from the Free Periods group, said "many schools and students [are] still not aware" of the scheme, which aims to help prevent children in colleges, primary and secondary schools missing lessons if they don't have access to products at home.

Teenagers can cash in Child Trust Funds



Children born from September 2002 were given vouchers by the government to invest for the future, with the money only accessible at the age of 18. The savings pots could now be worth more than £1,000, or more if parents added contributions. The idea was for children to have some savings at the age of 18, to assist with costs such as further education funding or living alone for the first time.

The government initially put £250 into the tax-free account during a child's first year, then added another £250 when he or she reached the age of seven. For lower-income families, the payment was £500. Parents, family and friends could also contribute to the account, up to set limits. The scheme was then scrapped entirely by the coalition government in January 2011. Child Trust Funds can be found using the Government Gateway service, which requires a login or registration. The Child Trust Fund unique reference number or national insurance number is also needed.

Education in England Annual Report 2020



The report has highlighted some gaps in provision, demonstrating that since the new SEND Code of Practice (2015), non-statutory funded pupils, who are likely to have Specific Learning Difficulties (SpLDs) might not be included in the data and are therefore not guaranteed to have received evidence-based support which meets their needs

It also found that disadvantaged pupils in England are 18.1 months of learning behind their peers by the time they finish their GCSEs – the same gap as five years ago.
